If the guest (adult) or parent/guardian of a child with dietary allergies is not satisfied with the above measures for a severe allergy, the guest or parent may opt to provide their own meals.

If TRP are not satisfied that they can guarantee safe preparation of meals for a guest with a severe allergy then they will ask that the guest (or parent/guardian) prepare their own meals onsite.
