DISASTER READY CHURCH WORKSHOP (ChEMP)

- What capacity does your church have? What would you like to do?
- · Make a plan and share it with ADRA. (ChEMP = Church Emergency Management Plan).



CONNECT WITH YOUR LOCAL GOVERNMENT

· Build a connection with your local government and ask for their feedback on your plan.




REVIEW AND REVISE YOUR PLAN
